

## ● 3 Months Free on any new Ethernet Leased Line when Customers sign up to a new contract for a Daisy Leased Line (“Offer”)

### Offer Terms and Conditions

The following terms and conditions govern the Offer.

1. Eligibility. The Offer is only available to business customers who have signed up to a new contract from Daisy Communications Limited (“Daisy”) for a new Daisy Ethernet Leased Line, such services are subject to status and there are minimum requirements (“Eligible Customers”) between the 1<sup>st</sup> December 2019 and 31<sup>st</sup> January 2020, or until the Offer is withdrawn (whichever is earlier) (“Offer Period”).
2. How to participate. Eligible Customers must sign up to a new Daisy Ethernet Leased Line for a minimum term of 36 months (“Qualifying Order”). Eligible Customers whose orders are not successful and/or whose orders are not accepted by Daisy within the Offer Period are not eligible.
3. Offer Contents. Eligible Customers who sign up to a Qualifying Order will receive 3 months of the Ethernet Leased Line for free, in the form of a monthly service credit which shall be calculated on the basis of three months rental charges divided by the contract length. For example, a service billing at £360 per month on a 36 month term shall be entitled to a monthly credit equal to £30 per month ( $£360 \times 3 / 36$ ), this credit will be applied automatically and will appear on the monthly invoice for the duration of the minimum term of the contract.
4. Amending or withdrawing the Offer. Daisy reserves the right to withdraw or amend this Offer at any time. Qualifying Orders must be entered into during the Offer Period and, in any event, before the Offer is withdrawn.
5. Non-transferable. This Offer can only be redeemed against the Customer’s account and cannot be used to pay for or off-set any other fees, charges or costs, nor any other Daisy account balances. There are no cash alternatives.
6. Daisy Terms and Conditions apply. These Offer Terms and Conditions apply in addition to the Daisy Terms and Conditions for the provision of Equipment, Maintenance Services, Consultancy Services, Hosting Services, Conference Calling Services, DDSP Services, WiFi Services, Daisy Fraud Guardian and Fixed Network Services available at <https://daisycomms.co.uk/terms-conditions/> (“Daisy Terms and Conditions”)
